

# The supplementary agreement

(With respect to the Purchase order dated March 26, 2020)

**Seller: ZHONG TOU INVESTMENTS LIMITED**

**Buyer: MINISTRY OF FOREIGN AFFAIRS AND TRADE HUNGARY**

Purchase and Seller contract Purchase Orders (" Purchase Order ") dated 26 March 2020 for 1000 PCS CWH-3010 Ventilators. During the performance of Purchase Orders, the buyer and the seller make changes to the contract. The changes are as follows:

1. The goods purchased by the Buyer are changed from CWH-3010 ventilators to LH8500 ventilators. The manufacturer is Nanjing Leji Medical Devices Co., LTD.

2. The delivery cycle has been changed by mutual agreement between the buyer and the seller. The Seller has delivered 500 PCS LH8500 ventilators to the Buyer before May 22, 2020 as agreed by both parties. Buyer approves the delivery time and quality of the 500 PCS LH8500 ventilators.

3. As agreed by both parties, the seller has prepared the remaining 500 PCS LH8500 ventilators and stored them in the warehouse of Tianjin

Tianfang Hi-tech Logistics Co., LTD., which is located at No. 98, Zhong huan nan Road, Dongli District, Tianjin. The Seller has advised the Buyer that the goods are ready and asked the Buyer to designate the delivery place for the remaining 500 PCS LH8500 ventilators. The Buyer has designated Beijing Capital International Airport as the delivery place for the remaining 500PCS LH8500 ventilators.

4. The Buyer shall arrange the transportation of the remaining 500 PCS LH8500 ventilators within 7 days after the signing of this Agreement, so as to avoid the loss of more storage costs to the Seller. After the buyer has determined the shipping time, the seller shall transport the remaining 500 PCS LH8500 ventilators to Beijing Capital International Airport before that time.

5. The Buyer acknowledges that the delivery time of 1000 PCS LH8500 ventilators by the Seller shall be within a reasonable delivery period, and the seller's performance shall not violate the United Nations Convention on contracts for the International Sale of Goods. After transporting the remaining 500 PCS LH8500 ventilators to Beijing Capital International Airport, the Seller shall be deemed to have fully fulfilled the obligations set forth in Purchase Orders signed on March 26, 2020 and the Supplementary Agreement signed this time.

6. This Agreement shall come into force upon being signed and sealed by both parties.
